This regulation prescribes the license requirements for senior medical personnel and other professional members of the staff of the Medical Bureau of the Board of Education.

Subject: **SCHOOL MEDICAL BUREAU LICENSE REQUIREMENTS**

Category: **PEDAGOGICAL PERSONNEL**

Issued: **January 1, 1991**

### **1. APPLICABILITY**

This regulation prescribes license requirements for senior medical personnel and other professional members of the staff of the Medical Bureau. There are no comparable New York State pedagogical certificates for these titles.

### **2. SATISFACTION OF REQUIREMENTS**

Requirements for these licenses must be satisfied as generally prescribed by Regulation C-205. Subdivision C-205.15 provides a one-year time extension for those required to hold a currently valid license to practice medicine in New York State, provided no such applicant is appointed prior to possession of the required license.

### **3. LICENSE REQUIREMENTS FOR ADMINISTRATIVE AND SUPERVISORY MEDICAL BUREAU TITLES**

#### **A. School Medical Director**

##### **1. Preparation**

- a. graduation from an approved medical school or medical college; and
- b. possession of a license to practice medicine in New York State with present registration under that license; and
- c. certification or eligibility in a medical specialty.

##### **2. Experience**

Eight years of approved and appropriate experience in the practice of medicine, including or supplemented by satisfactory administrative and supervisory experience over a period of two years.

#### **B. Assistant School Medical Director**

##### **1. Preparation**

Same as for School Medical Director.

##### **2. Experience**

Five years as a licensed, practicing physician in New York State and one year of satisfactory administrative experience.

**4. LICENSE REQUIREMENTS FOR NON-SUPERVISORY MEDICAL BUREAU TITLES****A. School Medical Inspector****1. Preparation**

- a. graduation from an approved medical school or medical college; and
- b. possession of a license to practice medicine in New York State with present registration under that license.

**2. Experience**

Three years of approved experience in the practice of medicine, two of which shall have been appropriate to the service to be rendered under the license and one of which shall have been an internship in a hospital approved by the American Medical Association.

**B. School Medical Inspector – Psychiatrist****1. Preparation**

- a. graduation from an approved medical school or medical college; and
- b. possession of a license to practice medicine in New York State with present registration under that license.

**2. Experience**

Five years of approved experience in the practice of psychiatry, including 800 hours of appropriate clinical experience in approved institutions for the treatment of mental defects.
